PROOF OF AN AUTHENTIC RELATIONSHIP - DOCUMENTS TOGETHER - EACH YEAR

- ☐ Marriage License
- ☐ Tax Returns
- ☐ House Title/Rent Agreement
- ☐ Utility Bills (gas/water/lights/TV/phone)
- ☐ Bank Accounts/Credit Card Statements
- ☐ Insurance (car/health/home)
- ☐ Phone/text/email/social media - examples of each
- ☐ Support Letters (family, friends, neighbors) – 3-5 letters
- ☐ Personal Support Letters
- ☐ Relationship Photographs – 10 to 15 favorite photographs
